Town Meeting Quorum

To consider whether the Selectmen shall vote to exercise the option to lower the Annual Town Meeting quorum as permitted by Chapter 92 of the Acts of 2020; provided however, that a vote to reduce the quorum under this Act requires the Selectmen to act in consultation with and the concurrence of the Moderator; and, provided further, that in no event shall the quorum be reduced to less than 10% of the number specified in the town bylaw.

II. Action

- A potential vote to exercise the option to lower the June 13th Annual Town Meeting quorum requirement.
- Vote to adjourn.
