Historic District Commission:
Addition of Property to the Historic District

58 Bedford Road:

The Historic District Commission (HDC) heard two motions, namely for the proposed addition of 58 Bedford Road to the Historic District and for the approval of the proposed warrant article for approval of the addition at Town Meeting. Property owners Katherine Mierzwa and Michael Gerstein joined the HDC for its discussion. Andrew Glass noted that the HDC had received approval from Massachusetts Historical Commission for the addition and would be meeting with both the Planning Board and Select Board before Town Meeting. Mr. Glass presented a brief history of the house and thanked Ms. Mierzwa and Mr. Gerstein for their careful stewardship of their house and grounds and for their generosity of joining the Historic District. Ms. Mierzwa and Mr. Gerstein expressed that by joining the Historic District, they sought to provide protection to the house so that it could continue to contribute to Lincoln's built environment for many decades to come. Dana Robbat spoke thanking Ms. Mierzwa and Mr. Gerstein for their generosity and for their important research into the house and grounds.
