Owner Betsy Dangel and architect Lisa Muskat came before the Historical Commission (LHC) to request demolition of parts of the existing house at 133 Weston Road. Ms. Muskat shared the plans with the LHC and gave a brief overview of the proposed project. Andrew Glass thanked Ms. Dangel and Ms. Muskat for their presentation and noted that the house had been constructed in the 1990s, had not been inventoried for the Massachusetts Historical Commission, and in his opinion, was not historically, culturally, or architecturally significant.

Hanscom ESPR request

Mr. Glass requested that Peggy Bozak research the files for the previous versions of the LHC's report in response to the survey, prepare a report with the new additions to the Town's historic districts since 2018, and report back to Massport consultant Virginia Adams.
