II. Updates and Discussions

- Advisory Shoulder Pilot update
 - Appt with SB on 6/21 to get their approval for final design
- Rt 2A 75% plan; MMNHP
 - Walk through of Paula Vaughn-MacKenzie's analysis of plan item by item
 - Concern about lack of crosswalks and general interventions - this is a different plan than the 2nd Toole design, doesn't seem intended to slow/calm traffic. Ask MassDOT why they took those things out.
 - Chris suggests field visit with John V
 - Focus should be on asking for things that were in Toole design that were designed to slow the traffic that have been taken out.
 - Ask MassDOT where it is they cannot achieve 4 ft shoulder
 - Presence of a high school should increase the need for safety elements
 - Perhaps reach out to MassDOT headquarters.
 - if they are removing & replacing guard rails - they can move them a little.
 - Guard rails should be more park-like. Guard rails also signal to drivers how fast they can expect to go.
 - MMNHP has a stake
 - All crosswalks should have RRFB flashing beacons
 - Could have town add paint at Mill St exit to narrow turn.
 - Discussion of further outreach - wait until after next Thursday. Possibly state reps.
 - JD to reach out to new director
 - Margaret moved BPAC accept all recommendations discussed during the meeting , JD second, passed unanimously via roll call vote, John Mendelson not present for vote
 - Margaret moved to delegate Ginger and Bob to pass notes on to Paula for wording of a memo and edit as necessary with Paula before June 30, JD seconded, passed unanimously via roll call vote, John Mendelson not present for the vote
