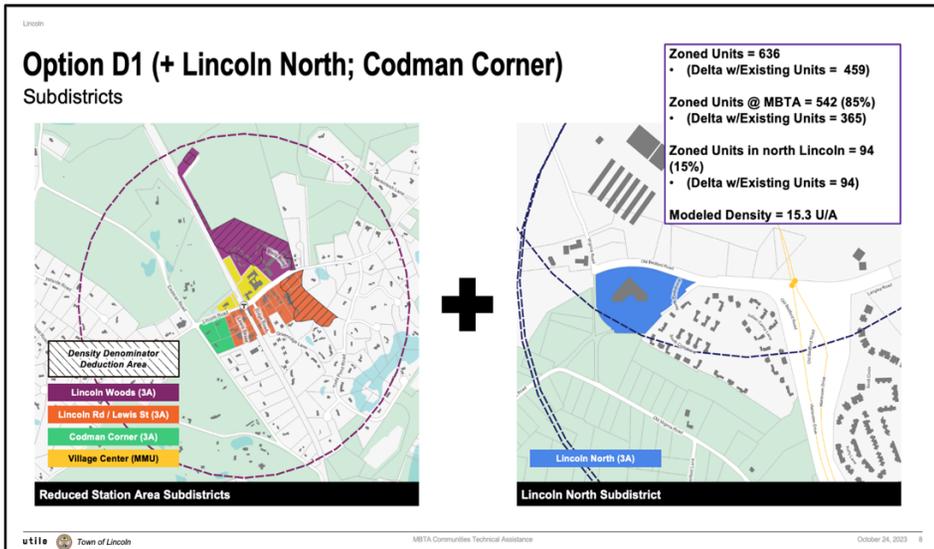

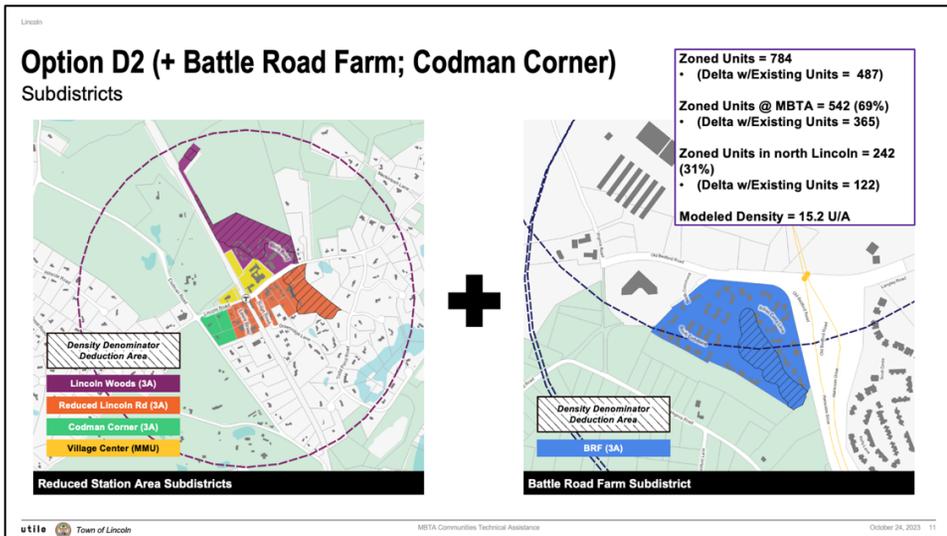

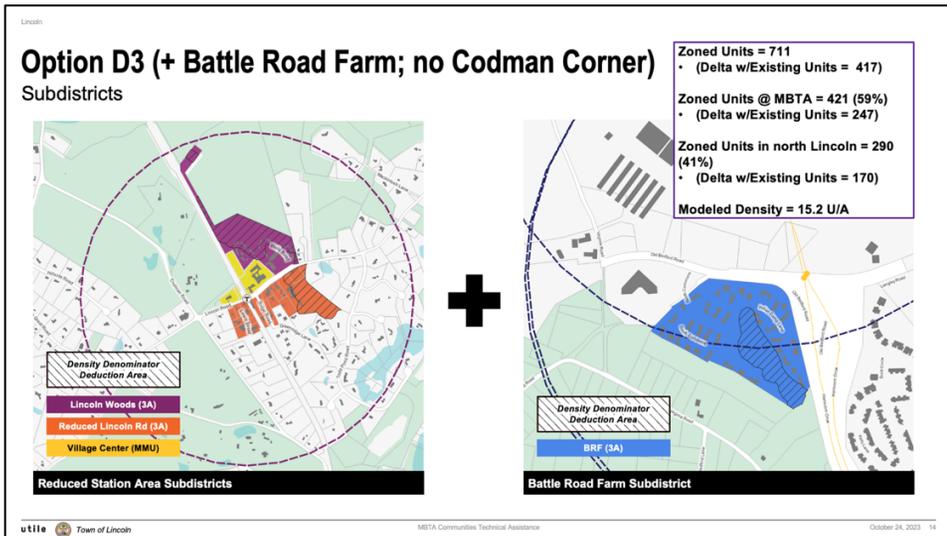

Option D3: Eliminates Codman Road subdistrict; reduces Lincoln Road/Lewis Street density; adds Battle Road Farm as a subdistrict (residential); takes credit for rezoning the Mall (commercial + residential)
